Primacenters: supporting migrants in the primary sector

As part of the **Primacenters**, we continue building strong alliances to support the socio-economic integration of migrants in the EU primary sector. Our focus is on creating networks that connect territories, organisations, and people committed to social inclusion and labour rights.

Highlights from Recent Activities

Greece – Supporting the integration in the primary sector

On **2 June 2025**, the Region of Peloponnese hosted a networking event bringing together stakeholders to disseminate the Primacenters project and promote the inclusion and dignified employment of migrants in the primary sector.

Key takeaways:

- Creating meaningful connections between migrants and local communities
- Inspiring inclusive employment through the sharing of practical strategies
- Nurturing sustainability and a spirit of cooperation

Belgium – Strengthening Integration Through Collaboration

On **28 May 2025**, KMOP hosted a networking event with professionals, experts, and stakeholders from the labour market, employment services, and migration sectors. The event provided a platform to exchange experiences and reinforce strategies to strengthen migrants' integration into the primary sector.

Key takeaways:

- Strengthened cross-sector collaboration
- Shared best practices for inclusion
- Identified areas for further support

Spain – Networking for Inclusive Solutions

In Spain, a networking event brought together migrant participants and local stakeholders to **share experiences, foster collaboration, and promote cooperative, sustainable, and inclusive solutions** in the primary sector.

Key takeaways:

- Enhanced connections between migrants and local organisations
- Exchanged practical strategies for inclusive employment
- Promoted sustainability and cooperative practices

Italy – Roundtable Discussions on Inclusion Challenges

LAND Impresa Sociale hosted **two roundtable discussions on 22–23 May 2025** in Sicily. Professionals working on social and labour inclusion discussed **real challenges**, including labour exploitation, access to essential services, and social invisibility. The discussions highlighted the urgent need for **more inclusive and coordinated support systems** at local and national levels.

Key takeaways:

- Highlighted urgent need for coordinated support systems
- Identified gaps in services and protection for migrants
- Fostered dialogue between local and national stakeholders

Cyprus – Building Partnerships for Integration

On **31 March 2025**, CARDET and the Cyprus Labour Institute – PEO hosted the first networking event in Cyprus. The event presented the Primacenters project and explored potential collaborations with organisations working with migrants and professionals in the primary sector. Participants exchanged insights and strategies to support migrants' socio-economic integration in agriculture, fisheries, and other primary industries.

Key takeaways:

- Established partnerships for ongoing collaboration
- Shared strategies to support migrant inclusion in agriculture, fisheries, and other primary industries
- Collected insights to refine the project framework

Next steps

- **Primacenters framework:** Partners will continue to refine the framework based on insights from focus groups, networking events, and stakeholder feedback, ensuring it addresses migrants' challenges effectively.
